

**Junior Gym School of Gymnastics
Policies and Effective Procedures
Contract and Terms**

The sport of gymnastics involves strenuous physical activity. Junior Gym Inc. takes all possible measures to ensure your child(ren)'s safety and well being. To the best of my knowledge my child(ren) is now in good health and is physically capable of participating in the gymnastic program offered by Junior Gym Inc.

I will not bring my child(ren) for his or her lesson if suffering from any respiratory, infectious or contagious disease.

MAKE UP CLASSES: In case of absences due to illness or emergency your child(ren) may have a make-up class provided space is available and you have given prior notice of cancellation. Maximum 2 hours per session based upon enrollment. Make-up classes cannot be accumulated, credited and made-up in advance, re-scheduled or carried into another session.

REFUND AND CREDIT: No refunds and credits will be issued for missed classes, registration fees, late withdrawals or any other session.

UNIFORMS: Proper gymnastics outfit is mandatory.

OBSERVATIONS: Limited to once per 8 weeks or last day of session.

HOLIDAYS: Please refer to session schedules.

REGISTRATION: Charged once a year on the anniversary of your entry in Junior Gym Inc., provided your enrollment is continuous throughout the year. Otherwise it is charged upon your return to Junior Gym each time.

TUITION PAYMENT: Your tuition is due (PAYABLE) in full before each session begins. Your child will not participate in the program unless payment is received in advance.

RELEASE: I hereby consent to my child(ren) participating in structured and supervised classes on equipment owned or used by Junior Gym Inc., and hereby agree that I for my child(ren) adopted or otherwise my heirs and executors waive and release any and all rights and claims for damages that in connection with my association, or entry in, gymnastics or other activities sponsored by Junior Gym Inc.

WITHDRAWAL PROCEDURES: If you wish to withdraw from Junior Gym Inc. your written notice in this must be received by the school 10 days prior to the end of the session. After your official withdrawal, you may re-enter Junior Gym Inc. at any time upon re-registration. However, if your notice is not received and you withdraw you are financially responsible for the next four weeks tuition.

PICTURES OR PHOTOS: Junior Gym Inc. may take photos during different special events, classes, camps, but not limited to these types of events. These photos may be used for promotional reasons, within Junior Gym Inc. or with their advertiser for advertisement purposes for Junior Gym Inc. The undersigned grants their permission for any photos of likenesses of their child(ren) to be used by Junior Gym Inc. or their representatives.

If any dispute arising from this agreement I undersigned agree to pay reasonable attorney's fees and costs, for Junior Gym Inc.
